



**POSITION OF BOARD OF DIRECTORS OF UNIPETROL, A.S. REGARDING REQUEST OF SHAREHOLDER –
ING. TOMÁŠ HÁJEK DATED 16 MAY 2016**

On 16 May 2016 UNIPETROL, a.s., Company ID no.: 61672190, having its registered seat in Praha 4, Na Pankráci 127, ZIP code 140 00, received a letter from Ing. Tomáš Hájek, shareholder of UNIPETROL, a.s. regarding request for explanation mainly relating to remuneration paid to key management personnel in 2015.
